2. Our clients are representative organisations who represent members in a wide scope of industries (which include *inter alia* business, manufacturing, agriculture, restaurants, and tourism).
3. It has been brought to our clients' attention that national government is currently considering various options regarding compulsory vaccination in response to Covid-19. It has also been brought to our clients' attention that government is ostensibly also currently consulting with various groups purporting to represent business regarding its planned measures.
4. It is our instructions to request information on the consultation process followed and the identification of entities to be consulted.
5. Our clients each have different perspectives regarding the appropriate government response to the issue. However, our clients are opposed to state-driven mandatory vaccination policies and monitoring mechanisms such as vaccine passports, penalisation and exclusion of unvaccinated persons, and regulatory obligations on business to aid and enforce mandatory measures.
6. We bring to your attention that our clients have not been consulted and that any process which purports to have done so, is flawed.
7. Therefore, our clients' request that government include our clients in its consultation process to ensure that all perspectives are recognised and considered.
